


3PT® frame-work for reforms

A framework which recognizes the fact that for any reform initiative to achieve its objectives, four fundamental aspects need to be done right, namely Policy, Process, People, and Technology. This model establishes the linkages between the three elements of reform initiatives namely Accountability, Transparency and Actionability and provides insights into weaknesses and issues in relation to accountability. This model helps in both conceptualization of policies/processes and in implementation.


AEM©
